EXECUTIVE ORDER TRANSFERRING BUDGET AND ADMINISTRATIVE  
FUNCTIONS OF THE OFFICE OF COMMUNITY SERVICE  
TO THE DEPARTMENT OF LABOR AND INDUSTRY

WHEREAS, there is an Office of Community Service established in the Office of the Governor under section 90-14-103, MCA; and

WHEREAS, the best interests of the State are served by combining similar functions as appropriate, in a manner which promotes efficiency in state government; and

WHEREAS, the function of the Office of Community Service is to foster and promote service to and volunteerism in the State of Montana; and

WHEREAS, the Department of Labor and Industry provides similar kinds of training and job service activities as does the Office of Community Service; and

1           WHEREAS, the Department of Labor and Industry is  
2 willing to administer the budget of the Office of Community  
3 Service.

5           NOW, THEREFORE, I, MARC RACICOT, Governor of the State  
6 of Montana, by virtue of the authority vested in me by the  
7 Constitution and laws of the State of Montana, do hereby  
8 direct the following:

9  
10           1.    The budget and fixed assets of the Office of  
11 Community Service will be transferred to the Department  
12 of Labor and Industry on July 1, 1995;

13  
14           2.    General administrative support for the Office of  
15 Community Service that includes legal, budgeting,  
16 record keeping, reporting, and related administrative  
17 functions of the agency will be provided by the  
18 Department of Labor and Industry as of July 1, 1995 and  
19 thereafter. The cost for this support will be funded  
20 from the resources of the Office of Community Service  
21 as required by the Department of Labor and Industry's  
22 indirect cost rate;



24           3.    The Office of the Governor will remain the  
25 supervisor of the Community Service Coordinator in the  
26 Office of Community Service, with assistance from the

1 Job Service Division Administrator and the Commissioner  
2 of the Department of Labor and Industry;


