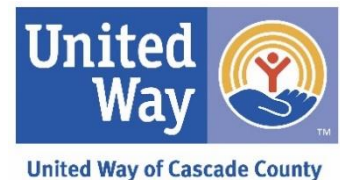

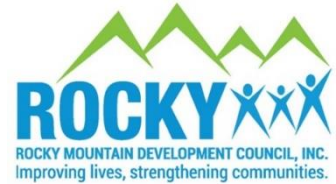
communities. Volunteers must be 55 years or older, willing to serve at least 20 hours per week, pass a background check, and meet income requirements to receive a tax-free stipend.
