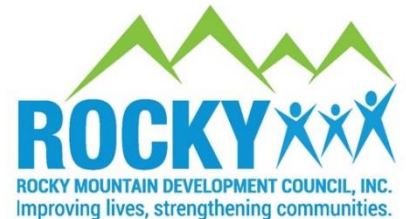

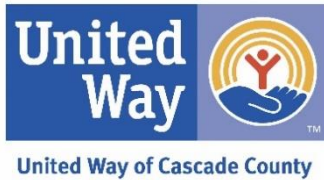
appointments, as well as companionship, friendship, and support. Their assistance helps these adults retain their dignity and remain independent in their homes rather than having to move to costlier institutional care.

Foster Grandparent Program Volunteers support in developing basic learning skills, sharing life experiences, and providing emotional support and one-on-one attention in areas of reading, writing, and math to prepare the children for independent living. Foster Grandparents are role models, mentors, and friends. The program provides a way for senior citizens to stay active by serving at-risk children and youth in their communities. Volunteers must be 55 years or older, willing to serve at least 20 hours per week, pass State and FBI Fingerprint Check, meet income requirements to received tax-free stipend, willing to share knowledge and experience with young children, and have compassion, enthusiasm, and patience to work with children.

Foster Grandparents receive a tax-free stipend of \$3.15 per hour effective July 1, 2022, Mileage reimbursement to and from assigned worksite, on-going training, annual volunteer recognition, supplemental insurance coverage while serving, socialization, and meet new people.
