- d. Commissioner Reports & Updates: Please share recent engagements with GOCS & local volunteerism
  - i. Commissioner Kipp: Presented a Youth Serve Montana scholarship to a student at Bigfork High School.
  - ii. Director Sadowski: Commissioner Ackerman presented a scholarship to a student at Florence-Carlton High School.
  - iii. Commissioner Swan: Had the opportunity to attend the Montana Student Volunteer Awards.

# II. 125p AC Mountain Region Office Update, Dylan Davids, Senior Portfolio Manager

- a. Next week, Carly Bruder, AmeriCorps Chief Program Officer, will join the Mountain Region Office staff to visit Commissions and service sites in Wyoming and Montana. They will visit several grantees and programs along with GOCS to learn about AmeriCorps in Montana. They are planning to travel back to Montana in July/August.
- b. AmeriCorps is processing applications across all streams of service.
- c. Big Sky Senior Service in Yellowstone County will start as a new AmeriCorps Senior Companion program on July 1<sup>st</sup>, AmeriCorps is excited about this expansion of service in Montana.
- d. RSVP programs are recompeting this year, a process that happens every six years. AmeriCorps is working to expand these programs into rural areas.
- e. Two Volunteer Generation Fund grantees, Montana Legal Services Association and Big Sky Youth Empowerment, along with one Native Nations Seniors project, Chippewa Cree, have been added as of late 2023.
- III. 140p State Service Plan Workgroup update & outreach, Commissioner Hawkins

- a. Workgroup has met several times to revise the community needs assessment questions and to talk about distribution efforts. OPI has sent the survey within the agency and in their newsletter that goes out to the schools.
- b. 92 responses so far with a goal of 5000 responses. More distribution efforts needed to reach this goal.
  - i. Commissioner Lawler: How long is the survey open? Director Sadowski: until the end of July.

    - 1. Helena Area Community Foundation is our partner for the finances for the memorial. Through their event, Greater Helena Gives, we have received \$1,100 for the memorial.

  - iv. June 13, AmeriCorps staff visit
    - 1. AmeriCorps leadership will be in Helena June 13<sup>th</sup>. Chair Harbage will join to represent the Commission.

- b. ServeMontana, Alyssa Mathieu, Program & Communication Specialist
  - i. Governor's Gift of Life Ceremony report out
    - 1. The ceremony was April 19<sup>th</sup> and hosted at the airport with Lieutenant Governor Juras. We honored 38 Montanans who combined saved 70 people. The architect was also able to attend the ceremony and brought the model of the memorial for the families to see.
  - ii. ServeMontana Awards, June 21

      - a. The event will be at 10:30am in the Rotunda with Lieutenant Governor Juras in attendance.

    - 1. Last Tuesday's meeting with AmeriCorps confirmed we should receive round 2 of funding this month.
    - 2. Director Sadowski and I are working with the DLI budget team to request additional funding in General Fund for the next biennium.

- d. AmeriCorps, Kristina Jordan, Program Officer & Elly Fisher, Training Specialist
  - i. Competitive Grants, funding determinations
    - GOCS received funding recommendations. Recompete applicant Montana Legal Services
      Justice for Montanans program and continuation applicant Montana Conservation Corps
      Big Sky Watershed Corps were funded at less than the requested amounts. Continuation
      applicant University of Montana, Montana Campus Compact AmeriCorps was funded at
      the requested amount.
    - 2. AmeriCorps shared that funding levels were based on FY22 retention rates.

#### ii. Formula Grants

- 1. Thank you to all who attended the special meeting of the Commission to vote on the funding recommendation.
- 2. All applications were submitted on May 31, 2024, anticipate AmeriCorps approval in July.
- 3. AgCorps and Fish, Wildlife & Parks AmeriCorps are the two Formula Program Grant applicants. Montana State University Office of Rural Health & Area Health Education Center, and Family Scholar House HealthCorps are the two Planning Grant applicants. Three innovation grant applicants are waitlisted pending AmeriCorps approval.

# iii. National Service Training

- 1. AgCorps' Amanda Coyle and Big Sky Watershed Corps' Bryan Wilson were in attendance in Minneapolis. Commissioner Turner, FWP AmeriCorps' Britney Stiles & Darby Bramble, and Justice for Montanans' Harley Ternes attended online.
- 2. Next year's training will be in Atlanta April 8-10, with a virtual option April 29-May 1.
