# II. 1030a AmeriCorps Office of Regional Operations (ORO) Update, Dylan Davids, Senior Portfolio Manager

- a. AmeriCorps VISTA & AmeriCorps Seniors Updates
  - i. Jill Sears, Regional Administrator, and Amy Busch, Deputy Regional Administrator, are present, and Becca Beckham, Portfolio Manager, will arrive later today.
  - ii. Staffing: Team South Portfolio Manager left in February. The team assigned to Montana and Idaho will be shifting to two portfolio managers with Becca remaining the portfolio manager for the Montana Commission.
  - iii. Agency: The Mountain Region is working with all streams of service on compliance with executive orders from the Trump-Vance administration. The review of existing awards is complete, and ORO is beginning work on new awards for FFY25.
  - iv. Program Updates
    - 1. ASN competitive continuations were returned on Monday to address potential resolution items, the competitive applications review process is ongoing.

- 3. AmeriCorps 2024 and 2025 General Terms and Conditions as well as 2024 ASN Specific Terms and Conditions have been updated to align with Executive Orders. New language was added to Certifications and Assurances.
- 4. Term Limits and Final Rule Updates
  - a. Members will be eligible for loan forbearance and interest accrual payment during either four terms or the length of time it takes to attain the aggregate value of the two full-time education awards, whichever is longer.

  - VISTA AmeriCorps will accept concept papers for FY 2025 Cycle 2 by March 27, 2025. Currently reviewing applications from Cycle 1. Will meet with VISTA project staff and members of five Montana projects here at the ServeMontana Symposium.

### vii. Funding Opportunities

- 2025 Native Nations Notice of Funding Opportunity, and 2025 AmeriCorps State and National Native Nations Planning Notice of Funding Opportunity, are now open.
- 2. This year's competition applicants may be eligible for 100% match replacement.
- 3. Applications due Wednesday, April 9, 2025, by 5:00pm EST. Successful applicants will be notified by end of May and issued awards by mid-July.

- a. MLK Jr. Day of Service was successful across the state.
- b. Staffing: GOCS has two postings for staff.
- c. Leadership Convening: In Washington D.C., Director Sadowski met with staff of Congressmen Daines, Zinke, Sheehy, and Downing, and attended Montana Coffee. Invited all Congressional delegates to visit an AmeriCorps program here in Montana during the August break.
- d. This is AmeriCorps Week. This year's ServeMontana Symposium planning committee was very engaged and are doing member interviews all week and posting to social media.
- e. Donate Life Memorial: GOCS will participate in Greater Helena Gives. The memorial honors all those impacted by organ, eye, and tissue donation.
- f. Commissioner terms: Chair Harbage, Commissioners Kirchberg, Myhre, Risberg, and Wetzel's terms are up in July. Please let Director Sadowski know if you are willing to serve another term and if not, please provide recommendations. Thank you, Commissioner Risberg, for your suggestion. - a. AmeriCorps, Kristina Jordan, Program Officer
  - b. Grants update: Competitive submitted two FY25 applications to AmeriCorps in January, decision expected in April or May. Formula received 7 Letters Of Intent: one continuation, one recompete, three new programs and two planning grants. Applications due April 17<sup>th</sup>, grant review workgroup meeting May 14<sup>th</sup>, and special meeting of the commission to vote on funding recommendation May 16<sup>th</sup> at 12p via Zoom.

- c. National Service Training (NST): Annual nationwide event sponsored by America's Service Commissions. GOCS requires all programs to attend this training, either in-person or virtually. Commissioners are welcome. April 8-10<sup>th</sup>, 2025 in Atlanta, GA, virtual April 29 May 1. GOCS and staff from all programs and planning grants will be in attendance; one program opted for virtual.

- a. Bryan Wilson, BSWC: Thank you for everything. The grant reviews and feedback are very helpful.
- b. Amanda Coyle, Ag Corps: Thanks for making the grant review process approachable, appreciate your time.
- c. Director Sadowski: Chair Harbage, we are grateful for your commitment and time on our Commission and for being helpful with this transition of Chair. Thank you to the GOCS staff

- for taking on additional tasks and making this year's ServeMontana Symposium happen. AmeriCorps Seniors, please nominate individuals for the ServeMontana awards so they can be recognized for their outstanding service.
- d. Angela Carter: We are a new Senior Companion program in Billings providing in-home care for low-income seniors. We will merge with another organization this summer and have completed first 1,000 hours of service.
- e. Theresa Boyer: We had a member who was not comfortable taking the small stipend, so she donates it back to the other seniors who need it.
- f. Angela Nelmark: One of our volunteers, Grandma Dan, is the longest volunteer, serving 36 years. She is 94 and served at Woodyear Elementary School in the after-school program. She was supposed to retire so we gave her an award and celebrated her on Thursday. We got a call on Monday that she was back at school because "she didn't know what else to do."
- g. Samara Lynde: I am very grateful for the 96 Senior volunteers ranging from 56-96 years old. They do many things including delivering 200 meals a day and the Go Getter Program which provides rides to medical appointments. The volunteers bring community to their clients.
- h. Jill Sears, AC: We have been in a handful of Commission meetings including other states and it is a real testament how strong service is in Montana with how many Commissioners sit on this board and how involved they are. Thank you for your service to your state and our nation.
- Amy Busch, AC: Montana is about serving each other and it stands out because Director Sadowski is a great leader and brings all streams of service together. Thank you, Chair Harbage, for your service.
- j. Kimberly Boyd: Last year we did a Veteran's Stand Down in Richland. It was amazing to be there with the big crowd as the veterans took down the flag. It was a very impactful experience.
- k. Carly Collins: The Billings Metro VISTA project is in its 15<sup>th</sup> year and VISTAs have raised over \$5.5 million and served at 60 host sites all over the state.
- l. Lisa LaMere: We had a dedicated Foster Grandparent in Billings who had to retire as she went blind. We still call her to check in as she cannot be with the kids at the daycare which was her reason to get out of bed.
