 - Release of 2024 proposed President's budget includes: 1.4 billion dollars for AmeriCorps the Agency, removing taxation of the Education Award, and increasing Member Living Allowance by 17 percent.

 - ii. The 2023 budget has been released.

- a. Jono McKinney from MCC: MCC is anticipating around 400 members this year.
 - i. Thank you to Director Sadowski for help with HB 573 (see below).
 - ii. MCC is working with Rep. Kassmier to pass HB 573 to exempt Montana Community Service Act Programs from State Procurement Laws for the purposes of contracting. In 2019, a law was passed to exempt such programs but with a \$12,501 cap. HB 573 proposes to remove that cap.
