- ii. Legislative Updates: OTO, HB585 Organ Donation Memorial, HB573 Procurement, HB856
 - 1. GOCS did receive One Time Only budget for the upcoming biennium, these resources will serve to match the Commission Support Grant ARP dollars.
 - HB585 signed into law by the Governor. OCS is now approved to build an outdoor memorial on the Capitol complex for Montana's organ donors by 2028. OCS is working on fundraising strategies for the memorial.
 - 3. <u>HB573</u> signed into law by the Governor, allowing state agencies to budget and expend resources to engage AmeriCorps service without having a cap.
 - 4. HB856 became law without the Governor's signature. HB856 'generally revises the capitol complex administration laws' and includes the Old Board of Health Building where OCS has functioned for decades becoming legislative space. OCS is working with the Dept of Administration to identify a reasonable location to relocate to, as well as resources to cover the costs of relocation, along with the likely increase in rent.
